

When all else Fails – ...Follow the Rules

Like most branches, we have always had a problem trying to meet the SIR goal of 70% attendance.

This year, we have maintained 78%. How did we accomplish this? It was simple...we followed the rules.

At the first BEC meeting of the year, the Board was presented with the previous year's attendance report. The members who did not meet the attendance minimums (dead wood) were identified. The Big Sir then called them to see if they really wanted to remain members. A few said no, others had legitimate problems and asked to go inactive. Although this cut into our membership numbers, our attendance rate jumped up.

We also designated a Branch Director as Attendance Monitor. Each month he reviews the luncheon attendance and calls all members who have missed the last three Luncheons without an excused absence. He then reports his findings at the next BEC meeting and recommends actions to be taken – a call from Big Sir, Form 4, Inactive status, etc. This has worked out extremely well for us. Although our membership has lost a few bodies, we have a much more active membership that participates in our Branch activities.

So...if your Branch has been unable to meet the SIR standard goal of 70%, check to see if you are following SIR rules 60, 100, 107 and if not, take appropriate action.

Spotlight on SIR Officers

Bob Hairston - 2015 State President

How did a shy mid-western boy end up as President of Sons in Retirement?

After growing up in the 60's outside of Chicago during the draft years, I enlisted in the Navy before getting drafted and volunteered for submarines. I went to boot camp and school in Great Lakes, Illinois. From there I went to submarine school in Groton, Connecticut and then to an aircraft carrier in San Diego. It was then onto Nuclear Power School in Vallejo, a prototype submarine in Idaho and then back to Vallejo to a submarine in the shipyard that was all in pieces.



When that submarine was back together and tested, it was sent to Charleston, South Carolina and after changing crews, we set off for Cape Kennedy, shot a test Poseidon missile and headed for the Panama Canal. I wonder how many of my readers have been lucky enough to go through the Panama Canal or have enjoyed a barbeque lunch on top of the missile tubes of a nuclear submarine. Once we arrived in Hawaii, we changed crews, met our wives and started a rotation that lasted four more years. During those four years, I earned my submarine qualification dolphins and ran the engine room on the submarine.

When I got out of the Navy, I applied at Mare Island Naval Shipyard in Vallejo. I did very well at Mare Island with my submarine experience. For the next nineteen years, I overhauled, tested and taught submarine equipment and systems. One of my favorite jobs was sea trials where the object was to break the equipment before it was turned back over to the submarine crew and I was very proud that the equipment held up. For eight of those years, I was an instructor teaching the shipyard employees how the submarine worked and submarine crews how the shipyard worked and sometimes the goals were different.

When I retired in 1995, I was asked to join Sons In Retirement by three fellow Mare Island guys. I was immediately placed on the BEC as a Director. My election to Little Sir soon followed and after that, I was the Big Sir in 1999 and 2000. I left that Branch and became golf chairman. After a year off, I became an Area governor, then a Regional Director and Vice-President in two year increments.

I have worked part-time for H&R Block, Waddell and Reed Financial Services, the Pepsi Golf Tour, and the Chardonnay Golf Club. I also finished my studies for a Bachelor's Degree and graduated from St. Mary's College. I met my wife, Mary, while in Nuclear Power School and we thought that was a good time to get married and our marriage has lasted for 43 years.

Don Dill - 2015 State Vice President

I was born in the Canadian Rockies in Nelson, British Columbia in 1938 and moved to Vancouver BC at the age of four where my sister and I lived with my mother while my father went off to WWII. I finished high school at University Hill High in Vancouver in 1956 and went immediately to the University of Arizona where I met Carol, my wife of 55 years. After graduation, I began a career in retail with the F. W. Woolworth Co. and spent the next 37 years starting as a Trainee, then Store Manager, District Manager, Loss Prevention Director and eventually the last 15 years as a Senior Director of Human Resources. I retired in 1998 and became an HR Consultant. We sold our home in San Mateo and moved to Auburn in the spring of 2001.



One day, I was dragged off the golf course by an overly aggressive Sir and I joined Branch 79. I became the Branch Golf Chairman and from there it was Area Golf Chairman and then I moved on to the State Golf Committee where I held a number of positions including: Division 2 Chairman, Policy Committee, Secretary, and Operations Chairman. My real love has been at the Branch level as Membership Chairman, Little Sir, Big Sir, and then Area Governor, Regional Director, and now 2015 Vice President Elect.

The most important thing that Sons In Retirement has given to me is an opportunity where one can develop Friends for Life. Throughout my business career, it was short-time corporate relationships that had left me with only three real friends after almost forty years spread from the Atlantic to the Pacific. But SIR – at the Branch (79) level – has provided me with friends that they write books about like...World War II heroes, tons of Air Force and Army guys, small business contractors run by basic get your hands dirty tradesmen, who will show you how to fix a pipe, run a back-hoe or repair your deck. These guys are **Friends for Life** and they are too numerous to list by name but far more than three. It is now time to give back more by assuming a leadership position and I ask my fellow Sirs to help **US** create a culture where others have the opportunity to find the same great organization that I have found in SIR.

Spotlight on SIR Officers

Derek Southern - 2015 State Secretary

I was born in North West England but lived near London until I went to Durham University and majored in Chemistry. This lead to a career in the separation sciences. I developed some new products and was transferred to the company's New Jersey subsidiary where I discovered that they needed me more for marketing than for my science background and so I earned an MBA with a focus on marketing and USA accounting. In 1979, a company in California offered me a job and I spent the rest of my working life marketing scientific products to companies around the world.



During my career, I worked twice with Walt Schick and when I retired in 1976, Walt invited me to a Branch 8 luncheon in Walnut Creek. I showed some interest in joining SIR and he asked me to help him edit the Branch newsletter. So, even before I was inducted in 2006, I was editing the newsletter. The next year, the Membership Secretary was unable to continue and I was offered that job. The records needed updating and combining into a database so mailing labels for the newsletter and the roster could be produced from a single file. I also taught myself about websites and became the Branch Webmaster in 2009. After three years, I was asked to stand for election as Little Sir and then I became the Big Sir in 2011.

International marketing required a lot of presentations and instructional sessions and I also taught MBA marketing for an online university since I could do that while traveling, even with slow modems. This expertise lead to me joining the INFOSYS Committee, then the Training Committee and finally the G&M team. In the latter, I examined historic SIR data and the Form 27 data that showed how just a few branches were really healthy and so many were not. This helped the SAT team alert Branches to the dangers of not recruiting enough new members to beat their attrition rate. Not a new concept, but the graphs I produced helped make the point to every Branch. This year, I was tasked with chairing the State Training Committee — a job almost completed — and when the opportunity came to volunteer as State Secretary, I applied and was voted in for the 2015 year.

Most people have never seen a 16-foot redwood log turned into lumber by an ancient steam-powered sawmill, but some Branch 76 members had the chance to do just that!

Sturgeon's Mill (see picture) is one of the world's last steam-powered sawmills that still uses its original equipment, and we had a free demonstration – it was real treat! The mill (see picture) is surrounded by a forest of redwoods and the property is loaded with all kinds of antique equipment. The visit here was a fun-filled trip back into time.

When the mill fired up its19th-century Atlas Steam Engine (see Picture), the sound filled the entire valley. Steam poured from the mill while the saw gained





speed. "People love watching a log being sawed up" said Bob Sturgeon, whose grandfather, Wade Sturgeon, built the mill a few miles away in 1913. Then in 1923, it was dismantled and brought to its present location outside of Sebastopol.

Aside from the mill and the gardens, Branch 76 members enjoyed the small museum with its ancient hand tools and other artifacts, logging trucks, the mill office with its manual typewriters, and the blacksmith shop.

The day ended with lunch served on picnic tables beneath the redwood trees. A great time was had by all!

From time to time, I hear comments from members like: "What does the SIR State do?" or "What has the SIR State ever done for us?"

Here are **some** of the things SIR State volunteers do:

A) SIR provides **INSURANCE** protection for all members engaged in officially designated functions. There are four categories of insurance coverage: **General Liability** (includes Vehicle, Liquor, Fire Damage, Voluntary Medical Payment, Property and Valuable Records, Fidelity Bond and Money/Securities); **Excess Liability** that extends basic liability coverage;

Directors & Officers Liability Coverage that covers unintentional negligent act errors or omissions; and **Certificates of Insurance** for owner/operators of facilities where SIR meets.

- B) SIR provides California and Federal **TAX FILING**. Each Branch is a separate Corporation and must be filed separately.
- C) SIR provides **LEADERSHIP AND ORGANIZATION.** The **SIR Manual** and **SIR Leaders Guide** provide operating rules and guidelines. SIR maintains a **State Roster**, membership records, financial records and statistics which provide operating information. SIR also provides Regional Director, Area Governor and Branch Officer (Big SIR elect, Secretary, Treasurer, etc.) **Training**.
- D) SIR provides **ACTIVITIES**, **RECOGNITION AND COMMUNICATIONS**. SIR State sponsored activities include **Golf**, **Bowling**, **Travel**, etc. The **certificates** for Honorary Life Members (HLM), Senior HLM, Senior (90 year old), Super Senior (95) and Century (100) are produced and distributed by SIR State. SIR also publishes this **newsletter** (SIR Happenings), maintains the State **Website** (sirinc.org) and manages the servers which host many of our Branch Websites.

So now you know!

If you want to know more of the things SIR volunteers do, look at the State Roster, especially all the State Committees. The Roster can be found on the State Website (sirinc.org).

January 13-28, 2015 Hawaiian Islands Cruise
